

PRIVACY POLICY

We protect the privacy and confidentiality of all the Personal Information of our Users, therefore, we have established this Privacy Policy which explains all the Personal Information we collect, as the purpose and treatment of such information. We strongly recommend that you read this Privacy Policy before accessing our Website and using our Services.

This document describes the privacy practices applied to the services we provide when you visit us at www.playerszone.tv. This Privacy Policy constitutes a contractual agreement between you and Players Zone.

Our Website (www.playerszone.tv), including its platform, website or device applications, hereinafter referred to as the "Website" and "Services", belongs to United Street Soccer, EIN# 46-4209346, legally incorporated and domiciled in the State of North Carolina, United States of America, collectively referred to as "We" and/or "Us" and/or "Players Zone".

In this Privacy Policy, everytime we mention "You", "Your", "User" or "Users", we will be referring to any visitor who may access, browse and use our Website and Services.

By accessing and/or browsing and/or creating a User Account and/or using our Website and Services, you express your understanding and acceptance to the transfer, processing, and use of your Information in accordance with this Privacy Policy. All of our Users are subject to the provisions of this Privacy Policy.

The definitions set out in our Terms and Conditions, as defined in Section 22 apply to this Privacy Policy.

The access and/or browsing and/or creation of a User Account and/or use of the Website and Services is subject to the provisions of this Privacy Policy.

We ensure that any Personal Information that you provide to us will be processed in accordance with the relevant Data Protection Principles and Personal Information Protection Acts as applicable.

Our privacy commitment includes ensuring the accuracy, confidentiality, and security of your Personal Information and allowing our Users to request access to, and correction of, their Personal Information.

We are committed to safeguarding the privacy of our Users. This Privacy Policy will apply in regards to the collection, use or disclosure of any of your personal information. The following Privacy Policy explains how we deal with all the information collected from you, including your personal information, and the options available for you in respect to the policies we follow.

1. COLLECTION OF YOUR PERSONAL INFORMATION.

The Personal Information collected by us will solely be used in reference to the Services provided by our Website. We will not share, sell, or trade this Information with any third parties. This does not apply to Information that is publicly available, which we may collect and display on our Website.

In this Privacy Policy, everytime we mention "Personal Information" and/or "Information" we will be referring to any information about you that we collect when you access our Website and/or create a User Account and/or use our Services.

a) INFORMATION YOU PROVIDE.

We will collect the information directly provided by our Users hereinafter referred to as "Personal Information" and/or "Information", when they create an account hereinafter referred to as "User Account", as follows:

- First Name.
- Last Name.
- Email.
- Type of individual (experienced player, coach or parent).
- Gender.
- Country.
- Newsletter Subscription to our (optional).
- Payment Method (Credit Card/Debit Card).

We do not retain Information from you regarding bank accounts, credit cards or other payment methods.

By providing your Personal Information, you grant us consent to collect and use it in accordance with this Privacy Policy and our Terms and Conditions.

We reserve the right to confirm and validate any Personal Information and any other information provided by you at any time. If we determine that the Personal Information provided by you is unlawful, erroneous or incorrect (totally or partially), we may suspend or cancel your User Account and your Membership.

We have the right to file any applicable claim or proceeding if you provide unlawful, erroneous or incorrect Personal Information, in addition to using any other legal remedy available according to applicable legislation.

b) INFORMATION WE COLLECT AUTOMATICALLY.

We automatically collect Information about you exclusively to record how you make use of our Website and Services, tracking your interaction with us for security, including Information about:

- IP address.
- Login.
- Tutorials and courses selected.
- Devices used.
- Any other information that can be collected automatically.

2. CONSENT.

By accepting this Privacy Policy you agree to grant us a non-exclusive, worldwide, perpetual, irrevocable, royalty-free, sub licensable (through multiple tiers) right to exercise the copyright, publicity, and database rights (but no other rights) you have in your Personal Information, in any media now known or that may be known in the future, with respect to your Personal Information, solely for the purpose of enabling us the use of the Personal Information you provide to us for the use of our Services, and to avoid the violation of any rights over that Personal Information.

By accepting this Privacy Policy you agree that Player Zone is the Data Controller of your Personal Information. We will only use your Personal Information in accordance with this Privacy Policy.

3. WHEN DOES OUR PRIVACY POLICY APPLY.

You should know that our Privacy Policy applies to the following situations and activities:

- Online activities: Any Personal Information collected from you when you access our Website and/or log in your Account and/or use our Services.
- Other: Any Personal Information collected from you when you contact us by email or through our Mailing Address.

4. WHEN DOES OUR PRIVACY POLICY NOT APPLY.

Our Privacy Policy does not apply to any Personal Information provided by third parties and/or publicly available and/or not subject to any restrictions. We are not responsible for the privacy practices of third parties.

5. WHAT WE DO WITH YOUR INFORMATION.

We collect, store and use your Personal Information in accordance with this Privacy Policy and with our Terms and Conditions to: verify your identity; provide you with our Services; process your Membership payments; identify your preferences and meet any regulatory requirements.

6. INFORMATION SHARED WITH THIRD PARTIES.

By accepting this Privacy Policy you consent us authorization to share your Personal Information with our service providers, under their corresponding privacy conditions.

By accepting this Privacy Policy you agree that our Service Providers will operate as Data Processors to your Personal Information.

7. RETENTION OF YOUR INFORMATION.

We may retain your Personal Information until necessary but for a limited period of time that may not exceed one (1) year since the cancellation of your User Account.

8. ACCESS TO YOUR INFORMATION.

You may issue queries or ask questions about your Personal Information at any time, by email or any other way as appropriate and we will provide said information.

9. RECTIFICATION OF YOUR INFORMATION.

You may request, at any time, rectification on your Personal Information if you consider your Personal Information is inaccurate or incorrect, or when you wish to update your Personal Information.

10. OBJECTION OR DELETION OF YOUR INFORMATION.

You may, at any time, object the use of your Personal Information or request its removal, once the period established in Section 7 of this Privacy Policy has ended. We may delete your Personal Information before the expiration of that period when such information is not necessary, at our sole discretion.

12. DATA PROTECTION.

The protection of your Personal Information is our priority. In this Section we describe how we handle the protection, confidentiality and security of the Information we collect from our Users.

a) HOW WE PROTECT YOUR INFORMATION.

We guarantee the privacy and confidentiality of your Personal Information and also guarantee that we have implemented physical and electronic security measures, as well as other appropriate administrative procedures to prevent unauthorized or illegal access by third parties to your Personal Information.

We will continually review and update our security policies and controls, as technology changes to ensure ongoing information security.

We implement and maintain reasonable and appropriate technical and organizational security measures to protect the personal data we process, from unauthorized access, alteration, disclosure, loss or destruction.

We protect your information safely in a high security data centre, adhering to stringent security controls, measures and protocols to safeguard the privacy of your information. While we shall use our best efforts to ensure that the privacy of all Information is kept secure, please note that it is an accepted fact that no data transmission conducted over the Internet and/or through other electronic channels can be guaranteed to be wholly secure. As such, please ensure that your information is not accessible or disclosed to anyone. offerings, and communications relevant to your use of our Website and Services. By accepting this Privacy Policy and our Terms and Conditions, you expressly agree to receive this information, and expressly accept to receive ads.

You agree that we may share and/or disclose your Personal Information in accordance with applicable law. 22. SEVERABILITY.

If a court of competent jurisdiction holds any provision of this Privacy Policy, to be invalid, such invalid provision shall be severed and have no effect on the remaining provisions of this Privacy Policy, and they shall continue in full force and effect.

23. NO THIRD PARTY BENEFICIARIES.

Nothing in this Privacy Policy, express or implied, is intended to or will confer upon any person other than you, any right, benefit or remedy of any nature whatsoever under or by reason of this Privacy Policy. No person other than you, may bring a cause of action pursuant to this Privacy Policy.

24. ASSIGNMENT.

You may not assign your rights or obligations under this Privacy Policy without our prior written consent. We may assign this Privacy Policy at any time in our sole discretion without any prior written consent by you.

25. INTERPRETATION.

The headings in this Privacy Policy do not affect its interpretation. The use of any gender includes all genders. The singular includes the plural and vice-versa. Where a word or phrase is defined, its other grammatical forms have a corresponding meaning. This Privacy Policy was originally prepared in the English language. Although we may provide one or more translated versions of this Privacy Policy for your convenience, the English language version of this Privacy Policy will be the governing version of this Policy Privacy in case of any conflict or discrepancy. In the event that an ambiguity or question of intent or interpretation arises, in any judicial proceeding or otherwise, the terms of this Privacy Policy will be construed as having been drafted jointly by the parties, and no presumption or burden of proof will arise favoring or disfavoring any party by virtue of the authorship of any provisions of this Privacy Policy.

26. GOVERNING LAW AND JURISDICTION.

This Privacy Policy, shall be governed by the laws of State of North Carolina, United States of America. In case of disputes, you expressly agree to submit to the exclusive jurisdiction of the courts of the State of North Carolina, United States of America.
